Spring has arrived, and even though it's still cold outside; the tease of warmer days has begun. Time to get our cars ready for "Happy Days"!!

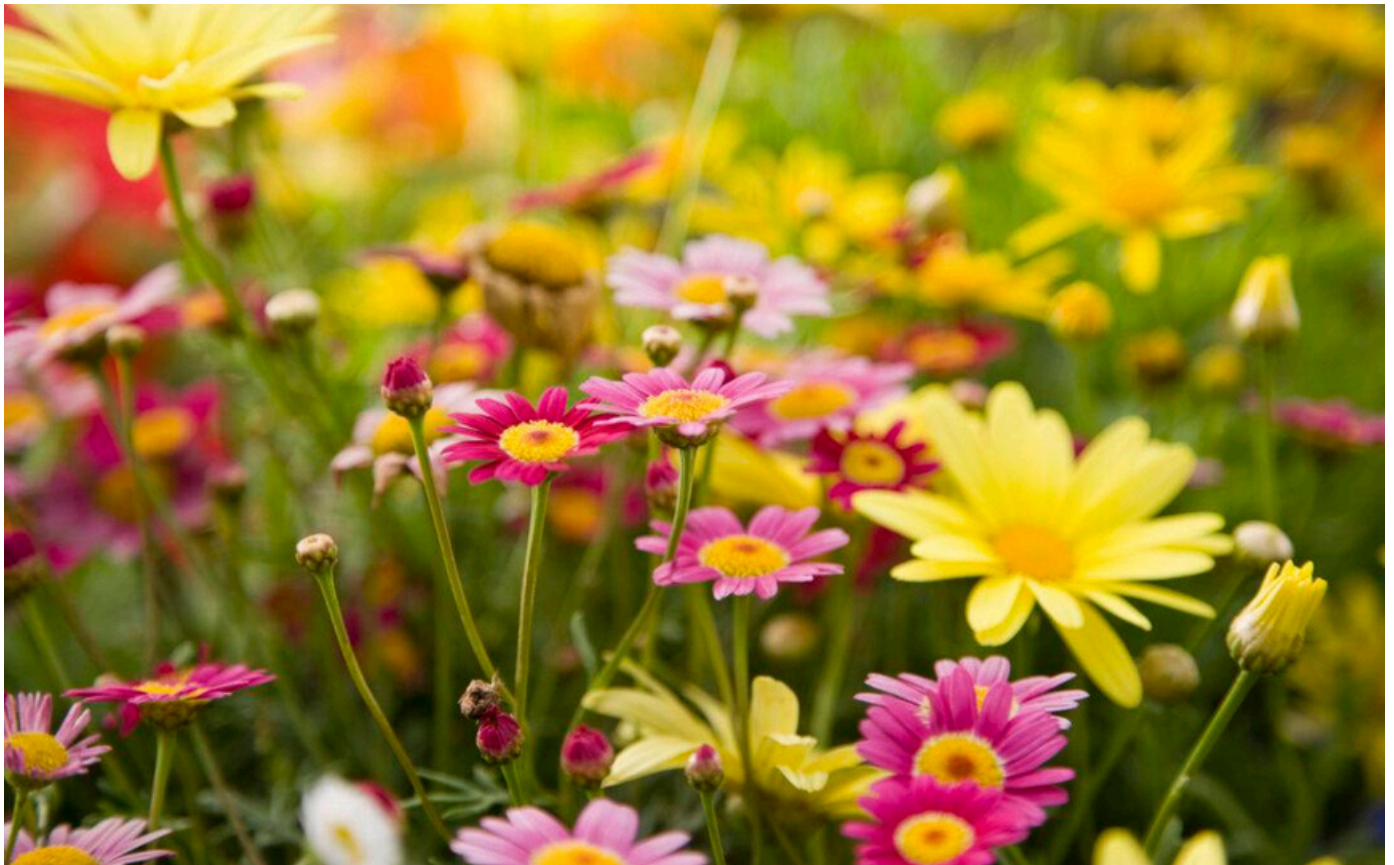

National Corvette Museum (NCM) Ambassador

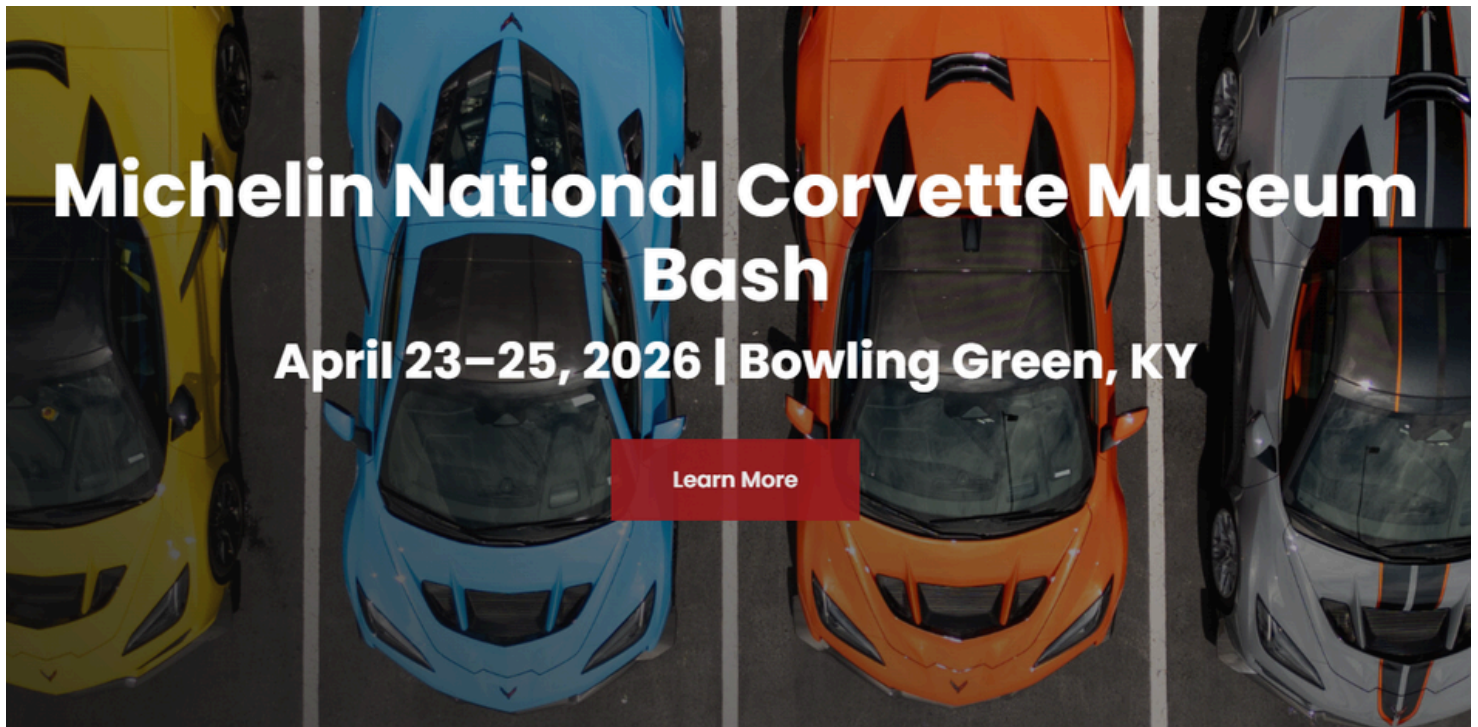
