Our May cruise to the Highland House had a nice turnout. Everyone seemed to enjoy themselves, and the food was delicious! The service was great too!

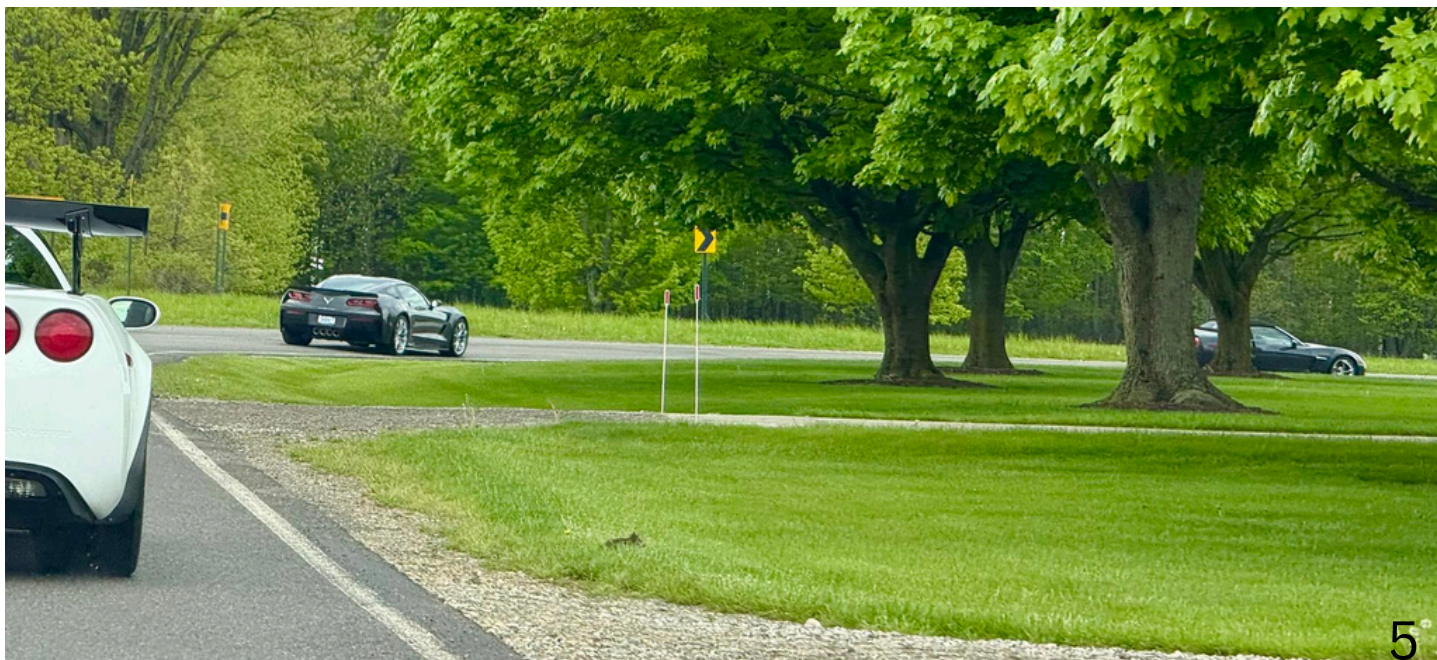
